

## II REGOLAMENTO

10th Lucca Half Marathon 2025

### OFFICIAL GUIDELINE

The ASD Lucca Marathon Sport Association organizes the 10th Edition of Lucca Half Marathon, with a length of 21.097 km. The race, included in the NATIONAL FIDAL calendar (Italian Athletic Federation) will take place on Sunday 4 May 2025.

#### Participation Requirements:

##### Italian athletes - members of a FIDAL society:

1. people over 18 years (thousandth of age), who are members of running teams affiliated to FIDAL (categories: Juniores, Promises, Seniors including the Master age groups).
2. people over 20 years (thousandth of age) who own a FIDAL runcard (the card issued by FIDAL official website [www.runcard.com](http://www.runcard.com)) and a competitive medical certificate for athletics valid up to May the 5th 2025: the medical certificate has to be submitted to the association at the address [iscrizioni@luccamarathon.it](mailto:iscrizioni@luccamarathon.it).
3. people over 20 years (thousandth of age), who own a Runcard EPS and medical certificate for athletics valid up to May the 5th 2025.
4. disabled people members of an association affiliated with a Paralympic Federation recognized by CIP (Italian Paralympic Committee) in convention with FIDAL. The athletes must submit a copy of the valid membership or a written declaration of membership with signature and stamp of the President of their society.

##### Italian athletes - without a membership:

Italian athletes, resident in Italy or abroad, which are not in possession of a FIDAL card or a Runcard/Runcard EPS must provide one to be allowed to participate.

#### ***THE PARTICIPATION IN THE RACE WITHOUT RUNCARD OR MEDICAL CERTIFICATE IS NOT ALLOWED.***

Please note that athletes with a Runcard or a FIDAL card cannot benefit from cash prizes or similar cases (value vouchers, bonuses, engagements, etc.), even if they enter the ranking.

##### Foreign athletes and Italian athletes that live abroad

1. people over 18 years (thousandth of age) who are members of running teams affiliated to Foreign Athletic Federations, affiliated to WA (formerly IAAF) or IPC; they must submit, at the moment of registration (via email [iscrizioni@luccamarathon.it](mailto:iscrizioni@luccamarathon.it)), a copy of the valid membership\* or a written declaration of membership with signature and stamp of the President of their society.
2. people over 20 years (thousandth of age) who own FIDAL Runcard combined with a medical certificate. The certificate\* can be issued in the country of origin, but the same tests required by the law must have been carried out; Italian legislation requires:
  - a. medical examination;
  - b. complete urine test;
  - c. electrocardiogram at rest and under strain;
  - d. spirometry.

Please note that athletes with a Runcard or a FIDAL card cannot benefit from cash prizes or similar cases (value vouchers, bonuses, engagements, etc.), even if they enter the ranking.

### PARTECIPATION FEES AND REGISTRATION METHODS

The participation fee is fixed as follows:

€25.00 from 01/12/2024 to 31/01/2024;  
€29.00 from 01/01/2025 to 29/02/2025;  
€32.00 from 01/03/2025 to 31/03/2025;  
€36.00 from 01/04/2025 to 24/04/2025;  
€ 40,00 from 25/04/2025 to 02/05/2025;  
€ 45,00 on the 3<sup>rd</sup> of May 2025 by the Expo

3) society registration: through the ENDU4TEAM application on the website [www.endu.net](http://www.endu.net) with costs of commission at a discounted price depending on the payment method, otherwise companies may send us an email at [luccahalfmarathon@evodata.it](mailto:luccahalfmarathon@evodata.it) - the signed declaration of the president that all of the athletes (listed on the same email) are in possession of a certificate and/or membership.

The payment of all registrations is to be made with a single bank transfer and a FLAT commission of 5€ at the bank address that can be requested at [iscrizioni@luccamarathon.it](mailto:iscrizioni@luccamarathon.it).

### **SERVICES INCLUDED IN THE PARTICIPATION FEE**

The participation fee includes:

- Race bib;
- Insurance and medical assistance;
- Official t-shirt;
- Race gift pack containing products offered by sponsors;
- Refreshments along the route;
- Official program and informative material;
- Race assistant service (pacers) from 1:24h to 2:00h
- Timing service with *CHAMPIONCHIP* technology
- Participation medal (for athletes who have reached the finish line);
- Showers by Campo CONI Lucca
- Certificate of participation (for classified athletes), that can be downloaded at [www.endu.net](http://www.endu.net) by selecting the event (Lucca Half Marathon 2025) and entering your bib number or your name and surname.

Massage service is available for all athletes.

### **Refund of Participation Fees**

Participation fees are non-refundable; however, we offer two alternatives:

- Transfer the registration to another person making your request no later than 20/04/2025, and by paying a supplement of €10 for secretarial fees. The person registered in replacement must provide all personal informations, runcard and medical certificate.

- Transfer the registration to the Lucca Half Marathon 2026 making your request no later than 20/04/2025; the fee will be considered automatically valid for registration to the Lucca Half Marathon 2025, without the possibility of further procrastination for the following year or transfer to ano-

ther person. To use the registration in 2025 you have to pay a fee of 10.00 euros at the time of the request in 2026 for secretarial fees.

## **REGISTRATION CLOSING**

Online and non-online registrations will close at 12:00 pm on 01/05/2025.

The ASD Lucca Marathon reserves the right to receive registrations in the days preceding the race and during the expo at a cost increased by 5€ compared to the last quote.

## **CONFIRMATION OF ENROLLMENTS**

It will be possible to verify the registration via [www.endu.net](http://www.endu.net) starting from 30 days following the execution of the registration itself. The bib number will be assigned automatically or decided at the discretion of the Committee 10 days before the race. It is not possible to request a particular bib number or to replace the already assigned bib number.

### **Bib collection**

The bib number and race pack can be collected personally at the Lucca Expo HALF Marathon located in LUCCA – Piazza Napoleone

- Friday 02/05/2025 (from 15.30 to 19.00)
- Saturday 03/05/2025 (from 9.00 to 19.00)
- Sunday 04/05/2025 (from 7:00 to 8:00).

It is not possible to send the bib in advance. When picking up the bib, the athletes must present a valid identity document. Bib numbers and race pack can also be collected by a third party, with a written proxy.

It is forbidden to modify the bib number in any way

## **BAG STORAGE**

A bag storage area will be set up at the Expo Lucca HALF Marathon. When leaving the storage, you'll need to apply the appropriate label, delivered together with the bib, on the bag, for allow easy return after arrival. The organization will take care of the baggage but does not guarantee refunds in case of loss.

### **Departure**

The departure is scheduled for Sunday 04 May 2025 at 9.00 from The Old Walls of the city of Lucca- Bqaluardo San Donato. In the starting area there will be toilet facilities.

## **TIMING**

The measurement of times and the elaboration of rankings will be carried out with a system based on an active transponder (chip) that will be delivered when collecting the bib (by Detecht/Mysdam). It is forbidden to tamper the chip. Athletes who damage the chip in anyway, or do not wear it, will not be timed and will not result in the rankings. For each athlete the following will be recorded: the official time (from the shot to the finish line), the net time (from the moment you cross the start line to the finish line), and the intermediate step in the middle of the race.

### **Time limits**

The maximum time is set at 2 hours and 30. After this time the organization will no longer be able to guarantee the complete closure of the race course. The athlete who passes halfway through the 10.5km with a time greater than 1:15h will be invited to retire by the organizers. The athlete who passes halfway through the 10.5km route with a time greater than 1:30h will be considered out of time.

### **Refreshments**

There are refreshment points at the finish line and every 5 km along the route. Water will be present in all refreshment points. Depending on the health rules in force, other refreshments may be expected. For hygienic-sanitary reasons, sponging is not foreseen.

### **Route Rules**

The route will be entirely closed to car traffic. The areas that cannot be closed will be effectively manned both by the police and by volunteers in charge of safety checks along the route. Vehicles not authorized by the organization are not allowed to transit the race course.

### **Race assistants (pacers)**

The organization will make available to athletes, several groups of race assistants (also called "pacers"), or athletes in charge of running the marathon at a constant pace to reach the finish line in a pre-established time. There will be race assistants with color balloon to finish the race in:

4.00'/Km ---> At the finish line in 1h 24'

4.15'/Km ---> At the finish line in 1h 30'

4.30'/Km ---> At the finish line in 1h 35'

4.45'/km ---> At the finish line in 1h 40'

5.00'/Km ---> At the finish line in 1h 45'

5.10'/Km ---> At the finish line in 1h 50'

5.25'/Km ---> At the finish line in 1h 55'

5:40'/Km ---> At the finish line in 2h 00'

The race assistants will be recognizable in the race by the vest showing the indication of the final time foreseen by the aforementioned colored balloons.

### **Finish line**

The finish line is located in Piazza Napoleone. Athletes who arrive regularly at the finish line will be entitled to the official medal of the race. After the finish line, the athletes will find: the refreshment area, the expo and the massage area.

### **Results**

The official results with partial and final times will be published on the website [www.luccamarathon.it](http://www.luccamarathon.it) or on the website [www.endu.net](http://www.endu.net) as soon as they are available and after validation by the Technical Delegate Judge/Appeal Judge.

### **Eventuality**

The event will take place in any weather condition. In the event that the race is canceled and/or postponed to another date, or in any case the race should not take place for reasons not attributable to the Organization, including the revocation of the authorization by the authorities, the members will have nothing to claim from Lucca Half Marathon, neither for the refund of the amount paid for the registration, nor for any expense incurred to stay in Lucca. The application for registration has the value of acceptance of this clause. In the event of cancellation and/or postponement of the race, the registration can be postponed to the following year. In this circumstance, the athlete will also be able to take advantage of the transfer option as indicated in this regulation.

### **Privacy and data processing**

The data controller is ASD Lucca Marathon.

The processing of personal data is carried out exclusively for the purposes related to the Lucca Half Marathon sporting event. The data provided will be processed in accordance with national legislation (Legislative Decree 196/2003 as adapted by Legislative Decree 101/2018) regarding the protection of personal data and with the EU European Regulation n. 679/2016. Pursuant to article 13 of Legislative Decree 30 June 2003, n.196 we inform you: that the data contained in the registration form is required for registration (in order to prepare the list of participants, the classification, the historical archive, to carry out the services declared in the regulation and to send athletes informational material from Lucca Half Marathon or its partners); that the consequences of failure to provide the data or information referred to above consist in non-admission to the event; that the

data can be communicated to CONI, FIDAL, WA (ex. IAAF), EA, EMA, CIO, and other public bodies (the data may also be communicated to national and international sports justice bodies); that, where necessary, the communication of the data provided may be made to third parties who provide collateral and instrumental services; that, for the right of reporting and documentation of sports activities, the data may be published by the means that the Data Controller deems most appropriate and in compliance and within the limits of the principle of essentiality; that the rights of the interested party in relation to the processing of personal data are listed in article 7 of the aforementioned Legislative Decree vo n. 196/03. At any time, the interested party can consult, modify, cancel their data free of charge by sending an email to the email address [iscrizioni@luccamarathon.it](mailto:iscrizioni@luccamarathon.it) or by writing to the person responsible for the processing of personal data at: ASD Lucca Marathon at the address indicated below.

## **IMAGE RIGHTS**

By registering at the 10th Lucca Half Marathon 2025, the athlete expressly authorizes the organization to acquire the free right, together with its partners, to use the still or moving images on which he may appear, taken on the occasion of his participation in the race, on all visual supports as well as on promotional and/or advertising materials, produced and disseminated throughout the world.

## **RESPONSIBILITY OF THE ATHLETE**

The athlete is responsible for the ownership and custody of his race bib, the exhibition of which guarantees the right to use all the services mentioned in these regulations. Anyone who, without regular registration, participates: 1. without a bib, in addition to being held responsible for damage to people or things, including himself, will incur in sporting sanctions under the jurisdiction of the federal bodies and in criminal penalties; 2. with a counterfeit bib or in any case not compliant with the assignment, or with someone else's bib, in addition to being liable as indicated above, he will incur in sporting sanctions and in criminal penalties. The aforementioned cases will be verifiable after verification of photographic and/or video documentation. It is forbidden to enter grids other than those assigned at the time of registration, as well as to throw, inside the starting grids and on the venue of the race course, t-shirts, capes or any other object that could cause hindrance or the fall of the athletes who might pass later. In the event of a violation, the athlete will be held liable for the damages caused, with consequent actions both in criminal and civil proceedings. It is forbidden to "cut" the established course and/or take shortcuts and/or enter the race course from a different point than the starting line. Failure to comply with this obligation will result in the disqualification of the athlete, as well as the liability of the same for any damage caused to third parties.

## **DISCLAIMER**

By accepting these regulations, the athlete expressly declares that he assumes all the risks deriving from participation in the event, such as, by way of example, any falls, contacts with vehicles and/or with other participants, spectators or other, adverse weather conditions, the conditions of the road surface, and any other different type of risk. As a result of this acceptance, the organizer and the individual subjects who participated in the organization of the sporting event are expressly exonerated from any liability for any damage or harm deriving from participation in the Lucca Half Marathon event.

## **FINAL WARNINGS**

The Organizing Committee, subject to authorization by FIDAL, reserves the right to modify these regulations at any time for reasons it deems appropriate for a better organization of the race. Any changes to services, places and times will be duly communicated to the registered athletes or will be reported on the official website of the event, [www.luccahalfmarathon.it](http://www.luccahalfmarathon.it). Furthermore, the documentation containing the essential information to take part in the race will be delivered by the organization together with the bib number. For anything not covered by this regulation, the statutory technical rules of FIDAL apply.
